

10 AND 11 TOWNSHIP 8 NORTH, RANGE 4 WEST OF AN ISLAND, WHICH MEANDER CORNER IS SOUTH 27.25 CHAINS FROM THE MEANDER CORNER TO SECTIONS 10 AND 11 ON THE RIGHT BANK OF THE COLUMBIA RIVER; THENCE ALONG THE MEANDER LINE IN SECTION 11 AS FOLLOWS: SOUTH 70° EAST 12 CHAINS; SOUTH 37° EAST 4 CHAINS; SOUTH 77° WEST 2.50 CHAINS; ALSO COMMENCING AT THE ABOVE POINT OF BEGINNING AND RUNNING ALONG THE MEANDER LINE OF SECTION 10 AS FOLLOWS: NORTH 87° 45' WEST 11.65 CHAINS; SOUTH 16° WEST 1 CHAIN; HAVING A TOTAL FRONTAGE OF 31.15 LINEAL CHAINS MEASURED ALONG THE MEANDER LINE, ACCORDING TO A CERTIFIED COPY OF THE GOVERNMENT FIELD NOTES OF THE SURVEY THEREOF ON FILE IN THE OFFICE OF THE COMMISSIONER OF PUBLIC LANDS AT OLYMPIA, WASHINGTON; ALSO.

ALL TIDE LANDS OF THE SECOND CLASS, OWNED BY THE STATE OF WASHINGTON, LYING BETWEEN THE LINE OF MEAN LOW TIDE AND THE LINE OF EXTREME LOW TIDE AND IN FRONT OF THAT PART OF LOT SEVEN, SECTION 10 T. 8 N. R. 4 W. W.M., MEASURED ALONG THE MEANDER LINE AS FOLLOWS: BEGINNING AT THE MEANDER CORNER TO SEC. 10 AND 11 TOWNSHIP 8 NORTH OF RANGE 4 WEST W.M. ON THE NORTH SIDE OF AN ISLAND, SAID CORNER BEING SOUTH 27.25 CHAINS DISTANT FROM THE MEANDER CORNER OF SAID SEC. 10 AND 11 ON THE RIGHT BANK OF THE COLUMBIA RIVER; THENCE RUNNING N. 87° 45' W. 11.65 CHAINS AND S. 16° W. 1 CHAIN TO THE TERMINAL POINT OF THIS DESCRIPTION, WITH A FRONTAGE OF 12.65 LINEAL CHAINS; ALSO

IN FRONT OF THAT PART OF LOT 8 SECTION 11 T. 8 N. R. 4 W. W.M. MEASURED ALONG THE MEANDER LINE AS FOLLOWS:

BEGINNING AT THE MEANDER CORNER ON THE NORTH SIDE OF THE ISLAND, AS ABOVE DESCRIBED, AND RUNNING S. 70° E. 12 CHAINS S. 37° E. 4 CHAINS, AND S. 77° W. 2.50 CHAINS TO THE TERMINAL POINT OF THIS DESCRIPTION, WITH A FRONTAGE OF 18.50 LINEAL CHAINS.
