BEGINNING, FOR THE DESCRIPTION OF SURVEY No. 959, AT CORNER No. 1, ON MEAN HIGH TIDE LINE OF CHIGNOK LAGOON AND NOT ESTABLISHED, FROM WHICH U.S. LOCATION MONUMENT No. 963 BEARS NORTH TWENTY-FOUR DEGREES, SEVENTEEN MINUTES EAST SEVENTY-NINE AND FORTY-NINE-HUNDREDTHS CHAINS DISTANT; THENCE SOUTH ONE AND SIXTY-EIGHT-HUNDREDTHS CHAINS TO WITNESS CORNER ^{TOSATD CORNER} No. 1, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 959 COR. 1 W.C. AND M.C., WITH MOUND OF EARTH, NINE AND SEVENTY-EIGHT-HUNDREDTHS CHAINS TO CORNER No. 2, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 959 COR. 2, WITH MOUND OF EARTH; THENCE WEST SIXTEEN AND ^{FORTY-}FOUR-HUNDREDTHS CHAINS TO WITNESS CORNER TO CORNER No. 3, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 959 COR. 3 W. C. AND M.C., WITH MOUND OF EARTH; SEVENTEEN AND SIX-TENTHS CHAINS TO CORNER No. 3, ON SHORE AND NOT ESTABLISHED; THENCE MEANDERING CHIGNIK LAGOON, NORTH ONE DEGREE, TWO MINUTES EAST FOUR AND ELEVEN-HUNDREDTHS CHAINS; NORTH TWENTY-TWO DEGREES, FIFTY-NINE MINUTES EAST SIX CHAINS, NORTH FIFTY-ONE DEGREES, FIFTY MINUTES EAST FIVE AND SIXTY-EIGHT-HUNDREDTHS CHAINS, NORTH FORTY-EIGHT DEGREES, FORTY-EIGHT MINUTES EAST FIVE AND SEVENTEEN-HUNDREDTHS CHAINS, SOUTH FORTY-FIVE DEGREES, SEVENTEEN MINUTES EAST NINE AND SIX-TENTHS CHAINS TO CORNER No. 1, THE PLACE OF BEGINNING, CONTAINING TWENTY-ONE AND FORTY-SIX-HUNDREDTHS ACRES;

LOCATION MONUMENT No. 953 BEARS NORTH FIFTY-ONE DEGREES, THIRTY-SIX MINUTES EAST ONE HUNDRED EIGHT AND THIRTY-EIGHT-HUNDREDTHS CHAINS DISTANT; THENCE NORTH SEVENTY-EIGHT LINKS TO WITNESS CORNER TO SAID CORNER No. 1, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S 1060 COR. 1 W.C. AND M.C., WITH MOUND OF EARTH; TWO AND THIRTY-ONE-HUNDREDTHS CHAINS TO CORNER No. 2, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 1060 COR. 2, WITH MOUND OF EARTH; THENCE WEST THIRTEEN AND FORTY-NINE-HUNDREDTHS CHAINS TO CORNER No. 3 AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 1060 COR. 3, WITH MOUND OF EARTH; THENCE SOUTH TWELVE AND NINETEEN-HUNDREDTHS CHAINS TO WITNESS CORNER TO CORNER No. 4, AN IRON PIPE, FOUR INCHES IN DIAMETER, THREE FEET LONG, MARKED WITH CROSS (X) AT CORNER POINT AND S. 1060 COR. 4 W.C. AND M.C., WITH MOUND OF EARTH; TWELVE AND EIGHTY-FOUR-HUNDREDTHS CHAINS TO CORNER No. 4, ON SHORE AND NOT ESTABLISHED; THENCE MEANDERING CHIGNIK LAGOON, NORTH SEVENTY DEGREES, SEVEN MINUTES EAST SEVENTY-THREE LINKS, NORTH FIFTY-EIGHT DEGREES, THIRTY-THREE MINUTES EAST FOUR AND SIXTY-SIX-HUNDREDTHS CHAINS, NORTH FORTY-SEVEN DEGREES, THREE MINUTES EAST TWO AND SIXTY-ONE-HUNDREDTHS CHAINS, NORTH TWENTY DEGREES, THIRTY-SIX MINUTES EAST FOUR AND SEVENTY-THREE-HUNDREDTHS CHAINS, NORTH SEVENTY-TWO DEGREES, FORTY-FOUR MINUTES EAST FIVE AND FORTY-NINE-HUNDREDTHS CHAINS TO CORNER No. 1, THE PLACE OF BEGINNING, CONTAINING NINE AND EIGHTY-FOUR-HUNDREDTHS ACRES;
