Stricklin. part of the second part, has GRANTED, BARGAINED and SOLD, and by these presents does Grant, Bargain, Sell and Convey unto the said party of the second part, and to his heirs and assigns, the following described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:

The (N. E. $\frac{1}{4}$) Northeast One-quarter, of the (S. E. $\frac{1}{4}$) Southeast One-quarter, of Section (9) Nine, Township (1) One, North, of Range (5) Five, East, of W. M.

Also starting at a point (20) Twenty, chains North of the (S. E.) Southeast corner. of Section (9) Nine, Township (1) One, North of Range (5) Five, East of W.
