THIS INDENTURE, Made this 21st day of May A.D. 1919 between J. F. Sweeney Sheriff of the County of Skamania State of Washington, party of the first part, and Sam T. Haskins of the County of ---- State of Illinois party of the second part, witnesseth;

THAT, WHEREAS, By virtue of an execution under foreclosure issued out of and under the seal of the Superior Court of the State of Washington, holding terms at Stevenson in and for said County, tested the 17th day of April A.D. 1918, upon a judgment recovered in said Court on the 10th day of April A. D. 1918, in favor of Sam T. Haskins and against William A. Burdick and Mary F. Burdick, husband and wife and to the Sheriff of said County duly directed and delivered, commanding him to sell the property hereinafter described, at public auction, according to law, as by the said execution under foreclosure reference being thereunto had, more fully appears;
