ROSE SHELLEY BY HUGH T. SHELLEY ADM. TO W. C. FRYE ET UX

KNOW ALL MEN BY THESE PRESENTS, THAT I, HUGH T. SHELLEY, A STEP-SON OF ROSE SHELLEY, DECEASED, DO HEREBY CERTIFY AND DECLARE THAT ON THE 28TH DAY OF NOVEMBER, 1919 W. C. FRYE AND CARRIE FRYE, HIS WIFE EXECUTED AND DELIVERED TO SAID ROSE SHELLEY THEIR CERTAIN PROMISSORY NOTES, AGGREGATING THE SUM OF FOUR HUNDRED DOLLARS, AND IN ORDER TO SECURE THE SAME, THEY ON SAID DATE EXECUTED THEIR CERTAIN MORTGAGE ON CERTAIN REAL PROPERTY SITUATED IN SKAMANIA COUNTY, WASHINGTON, IN FAVOR OF SAID ROSE SHELLEY, WHICH MORTGAGE WAS RECORDED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, ON THE 3RD DAY OF DECEMBER, 1919, IN BOOK "0" PAGE 235, RECORDS OF MORTGAGES FOR SAID COUNTY AND STATE.

THAT THEREAFTER SAID ROSE SHELLEY DIED TESTATE AND HER WILL WAS PROBATED IN THE COUNTY OF MULTNOMAH, STATE OF OREGON, AND I WAS APPOINTED EXECUTOR AS PROVIDED BY SAID WILL. THAT I PROVED SAID WILL AND HAVE FULLY ADMINISTERED UPON SAID ESTATE, PAYING ALL DEBTS AND LEGACIES.
