THE FIRST CONGREGATIONAL CHURCH to J. F. JACOBSEN et ux

THIS INDENTURE WITNESSETH, That The First Congregational Church of  
Stevenson Skamania County, Washington, a corporation organized under the laws of  
the State of Washington. parties of the first part, for and in consideration of  
the sum of One Hundred Dollars in lawful money of the United States of America,  
to them in hand paid by J. F. Jacobsen and Valleri Jacobsen, his wife, both of  
Stevenson, Wash. parties of the second part, have GRANTED, BARGAINED and SOLD,  
and by these presents do Grant, Bargain, Sell and Convey unto the said parties  
of the second part, and to their heirs and assigns, the following described real  
property, situate, lying and being in the County of Skamania and State of  
Washington, to-wit:

Lot numbered Eight (8) in Block numbered Two (2) of Upper Cascades  
Addition to the Town of Stevenson, Wash. according to the official plat thereof  
on file and of record in the office of the County Auditor of Skamania County, Wash.  
which Lot is more particularly described as follows, to-wit:

Commencing at the Southwest corner of said Block Two, thence N. 86 deg.  
34 min. E. along the North side of Hot Springs Alameda 49.35 feet, thence in a  
Northerly direction 123. 25 feet to a point on the South side of an Eight foot  
public sidewalk right of way 50 feet distant in an Easterly direction from  
Roosevelt St., thence following the South side of said right of way 50 feet in a  
Westerly direction to the East side of Roosevelt St., thence S. 0 deg. 21 min.  
W. 127.6 feet along the East side of Roosevelt St. to the point of beginning,  
being on the Southwest corner of said Block Two of said Upper Cascades Addition.
