MIKE JANKOSKA to VINCENT KONOPSKI

THIS INDENTURE WITNESSETH that Mike Jankoska, otherwise and in thpse certain deeds of conveyance from E. H. Prindle and F. C. Prindle, his wife, to grantor herein, dated August 24, 1908 and July 29, 1909, and recorded in Book L of Deeds, page _____, and Book L of Deeds, page 491, respectively, Records of the Auditors office of Skamania County, Washington, known and described as Mike Koska, for himself and as heir of Rosalia Jankoska, otherwise in said above described deeds described as Rosalia Koska, his deceased wife of Prindle, Washington, party of the first part, for and in consideration of the sum of Two Hundred Fifty Dollars (\$250.00), lawful money of the United States of America, to him in hand paid by Vincent Konopski of Bridal Veil, Oregon, party of the second part, has GRANTED, BARGAINED AND SOLD and by these presents does Grant, Bargain, Sell and Convey unto the said party of the second part and to his heirs and assigns, the undivided one-half interest now belonging to the grantor in and to the following described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:

Lots Five (5), Six (6) and Seven (7) in Block A of the town of Prindle as shown on the plat of said town now on file in the office of the Auditor of said Skamania County, subject to thpse certain conditions and restrictions set forth and contained in the said above described deeds from E. H. Prindle and F. C. Prindle, his wife.

TO HAVE AND TO HOLD the said premises, with all their appurtenances, unto the said party of the second part, and to his heirs, and assigns forever; and said Mike Jankoska, otherwise known as Mike Koska, party of the first part for himself and his heirs, executors and administrators, does hereby covenant to and with the said party of the second part, his heirs and assigns, that he is the owners in fee simple of the said undivided one-half interest in the said above described property as hereby conveyed, that same is free and clear of all incumbrances whatsoever, and that said
