CARSON TRADING COMPANY to M. L. THOMPSON et ux

THIS INDENTURE, Made this 16th day of April 1919, between Carson Trading Company, a Washington corporation, party of the first part, and M. L. Thompson and M. S. Thompson, husband and wife, parties of the second part, witnesseth;

That, whereas, at a special meeting of the stockholders of said corporation held on the 16th day of April 1919, for the purpose of determining whether or not the property of said corporation should be sold, at which said meeting were present all the stockholders of said corporation, the following resolution was unanimously adopted, to-wit:

"Whereas, the entire capital stock of the Carson Trading Company is held by M. L. Thompson and M. S. Thompson, husband and wife,

And, Whereas, the business of said corporation could be better transacted by said M. L. Thompson and M. S. Thompson as individuals,

Therefore, in order to place the assets of the company in better form for the purpose of dissolving and disincorporating said corporation,

BE IT RESOLVED, that all the property of the said corporation be sold and transferred to the said M. L. Thompson and M. S. Thompson for the sum of \$6000.00 and that their note payable on demand be taken in payment thereof, and that the President and Secretary execute a deed and Bill of Sale for said property."

Now, Therefore, in consideration of the premises and of said sum of \$6000.00 to it in hand paid, the receipt whereof is hereby confessed and acknowledged, the said party of the first part does hereby GRANT, BARGAIN, SELL and CONVEY unto the said parties of the second part, and to their heirs and assigns the following real and personal property in Skamania County, State of Washington, to-wit:

Beginning at a point 30 feet East and 130 feet South of the Northwest corner of the Northeast quarter of the Northeast quarter of Section Twenty-nine, Township Three North of Range Eight East of the Willamette Meridian, running thence East 110 feet, thence South 50 feet, thence West 110 feet, thence North 50 feet to the place of beginning, being Lot Three of Block A of the original townsite of Carson.

Also; Beginning at a point One Hundred Sixty-five (165) feet South and Thirty (30) feet West of the Northeast corner of the Northwest quarter of the Northeast quarter of Section Twenty-nine (29) in Township Three (3) North of Range Eight (8) East of the Willamette Meridian, running thence West 100 feet thence South Sixty (60) feet, thence East One Hundred feet (100ft) thence
