

FREDERICK D. KRIBS et al to E. C. AMANN

KNOW ALL MEN BY THESE PRESENTS, That we, Frederick D. Kribs and George A. Kribs, of the County of Multnomah, State of Oregon both single, being of lawful age, in consideration of Ten and no/100 Dollars, to us paid paid by E. C. Amann do hereby REMISE, RELEASE and forever QUITCLAIM unto the said E. C. Amann and unto his heirs and assigns, all our rights, title and interest in and to all that parcel of real estate situate in the County of Skamania State of Washington, to-wit:

SE $\frac{1}{4}$  and NE of SW of 17; the E $\frac{1}{2}$  and SE of NW and Lot 4 of 19; and all of Sec. 21, and the N $\frac{1}{2}$  of Sec. 28; the N $\frac{1}{2}$  <sup>and</sup> ~~of~~ the SW $\frac{1}{4}$  and the SE of SE and W $\frac{1}{2}$  of SE of Sec. 29; and the E $\frac{1}{2}$  and the E $\frac{1}{2}$  of the W $\frac{1}{2}$  and Lots 1, 2, and 3 of Sec. 30; the NE $\frac{1}{4}$  and E $\frac{1}{2}$  of the NW $\frac{1}{4}$  and N $\frac{1}{2}$  of SE $\frac{1}{4}$  of Sec. 31; and all of Sec. 32; all in Township 3 N. Range 7 E., Skamania County, Washington.

The purpose of this deed is to remove a possible cloud on the grantee's title to said land caused by the grantors' claim thereto, and the grantee in accepting this deed agrees not to use it as a basis of a claim to a title acquired after the date of the sale to him under order of Court, and not to use it to impair or defeat the right of redemption now standing against the grantee's title to said land.

TO HAVE AND TO HOLD, the same, with all the privileges and appurtenances thereunto belonging to said E. C. Amann and to his heirs and assigns forever
