

5. ALSO ALL THOSE CERTAIN PORTIONS OF STREETS IN THE CITY OF VANCOUVER, WASHINGTON, THAT HAVE BEEN DULY VACATED BY ORDINANCES OF THE CITY OF VANCOUVER, WASHINGTON, SAID ORDINANCES BEING NUMBERED 1118-1166-¹¹⁹²1196-1199 AND 1226 SAID VACATED PORTIONS INCLUDED HEREIN BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

(A) ALL OF INGALLS STREET (FORMERLY KNOWN AS "I" STREET) LYING SOUTH OF THE SOUTH LINE OF FIFTH STREET.

(B) ALL OF HARNEY STREET (FORMERLY KNOWN AS "H" STREET) LYING SOUTH OF THE SOUTH LINE OF FIFTH STREET.

(C) ALL OF FOURTH STREET LYING BETWEEN THE WEST LINE OF GRANT STREET (FORMERLY KNOWN AS "G" STREET) AND THE EAST LINE OF HARNEY STREET (FORMERLY KNOWN AS "H" STREET).

(D) ALL OF GRANT STREET (FORMERLY KNOWN AS "G" STREET) LYING BETWEEN THE SOUTH LINE OF FIFTH STREET AND THE NORTH LINE OF THE CITY LEVEE.

(E) THAT PORTION OF FIFTH STREET DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF FRACTIONAL BLOCK 57 IN THAT PART OF THE CITY OF VANCOUVER, WASHINGTON, LYING WEST OF MAIN STREET AS LAID OFF AND PLATTED BY ESTHER SHORT, AND RUNNING THENCE EAST 860 FEET, MORE OR LESS, TO A POINT THAT IS 30 FEET WEST OF THE NORTHEAST CORNER OF LOT 4 IN BLOCK 37 AS SHOWN UPON SAID PLAT; THENCE NORTH 10 FEET; THENCE WEST 20 FEET; THENCE NORTHWESTERLY TO A POINT THAT IS 20 FEET NORTH OF THE NORTHEAST CORNER OF BLOCK 46 AS SHOWN UPON SAID PLAT; THENCE WEST 760 FEET, MORE OR LESS, TO A POINT DUE NORTH OF THE PLACE OF BEGINNING; THENCE SOUTH 20 FEET TO THE PLACE OF BEGINNING.

(F) BEGINNING AT A POINT WHICH IS 36.08 FEET WEST AND 20.49 FEET SOUTH OF THE INTERSECTION OF THE CENTER LINES OF FIFTH AND GRANT STREETS IN SAID CITY OF VANCOUVER, WASHINGTON, (SAID GRANT STREET BEING FORMERLY KNOWN AS "G" STREET) AND RUNNING THENCE EAST 17.83 FEET TO THE NORTHEAST CORNER OF THE COLUMBIA RIVER PAPER COMPANY'S MILL BUILDING; THENCE SOUTH 2.23 FEET; THENCE IN A NORTHWESTERLY DIRECTION 17.97 FEET TO THE PLACE OF BEGINNING.

SUBJECT, HOWEVER, TO THE RIGHTS OF THE NORTH COAST POWER COMPANY AND ITS ASSIGNS IN AND TO THAT PORTION OF SAID VACATED STREETS ABUTTING THAT PART OF LOT 3 IN SAID BLOCK 57 THAT LIES NORTHEASTERLY OF THE NORTHERN PACIFIC RAILWAY COMPANY'S RIGHT-OF-WAY.

ALSO SUBJECT TO THE RIGHTS GRANTED TO THE PORTLAND VANCOUVER & YAKIMA RAILROAD COMPANY BY FRANCHISE ORDINANCE NO. 180 OF THE CITY OF VANCOUVER, WASHINGTON, AND AFFECTING SAID RAILROAD RIGHT-OF-WAY OVER THE VACATED PORTIONS OF INGALLS, HARNEY AND FOURTH STREETS AND OVER THE WEST END OF THE VACATED PORTION OF FIFTH STREET.

6. LOT TWO (2) IN SECTION FIVE (5), TOWNSHIP TWO (2), NORTH OF RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN.

THE SOUTH HALF AND THE SOUTH HALF OF THE NORTH HALF OF SECTION EIGHT (8) OF TOWNSHIP TWO (2) NORTH RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN.

THE SOUTH HALF OF SECTION NINE (9) TOWNSHIP TWO (2) NORTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN.

THE WEST HALF OF SECTION SEVENTEEN (17) OF TOWNSHIP TWO (2), NORTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN.
