O'Neill, a single man, hereby SELL, ASSIGN and TRANSFER all my right, title and interest in and to that certain contract and agreement made on the 20th day of Dec., 1913, by and between Dan J. O'Neill, a single man, the party of the first part, and James A. Haran, party of the second part, wherein and whereby I sold and assigned to the said James A. Haran all my right, title and interest in and to the following described real property situated in Skamania County, State of Washington, and described as follows, to-wit:
