

HARRY OLSON to MARY V. OLSON

THIS INDENTURE WITNESSETH, That Harry Olson party of the first part, for and in consideration of the sum of One Dollars lawful money of the United States of America, to me in hand paid by Mary V. Olson party of the second part do by these presents REMISE, RELEASE, CONVEY and QUITCLAIM unto said party of the second part her heirs and assigns, all interest of the said party of the first part in and to the following described real property, situated in Skamania County, State of Washington, to-wit:

Commencing at a point from which the corner Sections Fourteen, Fifteen, Twenty-two and Twenty-three, Township 3, North of Range Ten East of W. M. bears North 0° 7' East 1335.50 feet distance, said point being identical with the quarter corner of Sections 22 and 23, same Township and Range, and marked with an iron pipe: thence South 0° 7' West 1335.50 feet to the quarter corner of Sections 22 and 23, thence South 0° 7' West 1052.4 feet to meander corner for Sections 22 and 23, thence along meander line South 52° East 342.20 feet to a point, thence along same line South 84° East 3387.66 feet to the Southeast corner, thence along East line North 0° 6' East 2639.30 feet to the Northeast corner: thence along North line 656.13 feet West to the quarter corner of the initial point, said tract containing 38.67 acres more or less,

Also Lot One in Block One, and Lot Three, Six, Seven, Eight, Nine, Ten, Eleven, Twelve, Thirteen, Fourteen, Fifteen and Sixteen of Block One of the Town of Underwood,

Also Lots number 17, 18, and 19 of Block One of the Town of Underwood,

Also Lots 1, 2, 3, and 4 and Six, Eight, Nine and Ten, of Block Two of the Town of Underwood,

All of the foregoing property being in Skamania County, Washington.

TO HAVE AND TO HOLD, the said premises, with all the appurtenances, unto the said party of the second part, and to her heirs and assigns forever.
