

"The course of the center line of the main track of the railroad of Oregon-Washington Railroad & Navigation Company across that portion of said donation land claim in which the premises hereby conveyed are situated is particularly described as follows;

"Beginning at a point in the South line of said donation land claim, which is also the North line of lot Five of said Section Two (2), 900.6 feet East of a corner of said donation land claim, said corner being 10 chains South of the Northwest corner of said claim No. 37; thence Northwesterly on a 3 degree curve to the right, the tangent of which curve at the point of beginning makes an angle of 19 degrees 13 minutes with the said South line, a distance of 472.6 feet to a point; thence on a tangent 590 feet, more or less, to a point in the West line of said donation land claim."

8. All lands and interest in lands in the State of Washington owned by the grantor herein, whether or not specifically described in this deed.

9. All lands and interest in lands in the State of Oregon, owned by the grantor herein, whether or not specifically described in this deed.

TO HAVE AND TO HOLD the above described and granted premises, and all rights of the grantor herein, unto the said grantee, its successors and assigns forever, in fee simple.

And the said grantor, for itself and its successors and assigns, does hereby covenant with the said grantee, its successors and assigns, that it is seized in fee simple of the said premises; that said premises are free from all liens or incumbrances, and that it will WARRANT and DEFEND the same against the lawful claims and demands of all persons whomsoever.
