TERRITORY OF HAWAII
OFFICE OF THE ATTORNEY GENERAL

WHEREAS, Under and by virtue of an Act of the Congress of the United States of America, entitled "An Act to provide a Government for the Territory of Hawaii," approved on the 30th day of April, 1900, the appointment and removal of all Notaries Public within and for the Territory of Hawaii was vested solely in the Attorney General of said Territory:

NOW, THEREFORE, I, Harry Irwin of Honolulu, ^{City & County of Honolulu} Territory of Hawaii, the duly appointed, commissioned, qualified and acting Attorney General of said Territory, do hereby certify that Wade Warren Thayer, of Honolulu County of Honolulu Territory of Hawaii, was on the 2nd day of January, A.D. 1917, duly appointed and commissioned as a Notary Public for the First Judicial Circuit of the Territory of Hawaii; that on the 24th day of June, A.D. 1919, his commission as a Notary Public remained in force and unrevoked, and that on said day he had full power and authority under the laws of the Territory of Hawaii to act as a Notary Public in said First Judicial Circuit of said Territory and to administer oaths, and take and certify acknowledgments of deeds and other conveyances of land in said Territory. That I am acquainted with his handwriting and verily believe that the signature appended to the foregoing instrument is his signature.
