435 THIS AGREEMENT MADE AND ENTERED INTO THIS 31ST DAY OF MARCH, 1925, BY AND BETWEEN H. R. ALBEE AND JANIE ALBEE XXXXX, HIS WIFE, HEREINAFTER CALLED THE FIRST PARTIES, AND EVANGELINE VAIL-SNYDER, HEREINAFTER CALLED THE SECOND PARTY, WITNESSETH:

THAT WHEREAS, ON OR ABOUT THE 17TH. DAY OF MARCH 1920, SAID FIRST PARTIES, FOR VALUABLE CONSIDERATION TO THEM IN HAND PAID BY SAID SECOND PARTY, DID MAKE, EXECUTE AND DELIVER TO SAID SECOND PARTY THEIR CERTAIN PROMISSORY NOTE IN THE SUM OF TWELVE HUNDRED (\$1200.00) DOLLARS, PAYABLE ON THE 17TH. DAY OF MARCH, 1923 WITH INTEREST AT 7%; AND
