DAY OF MARCH, 1928, BUT IN NO WISE DOES THIS AGREEMENT ENLARGE ANY OF THE RIGHTS OF SAID FIRST PARTIES, OR CURTAIL ANY OF THE RIGHTS OF SAID SECOND PARTY, EXCEPT AS TO THE TIME OF PAYMENT AS HEREIN-ABOVE SET FORTH;

AND SAID FIRST PARTIES DO HEREBY PROMISE AND AGREE TO PAY SAID PROMISSORY NOTE ON THE 17TH. DAY OF MARCH, 1928, AND TO PAY INTEREST THEREON AT THE RATE OF 7% PER ANNUM, SAID INTEREST BEING PAYABLE SEMI-ANNUALLY, AND SUBJECT TO THE SAME TERMS AND CONDITIONS AS IN SAID PROMISSORY NOTE AND MORTGAGE SET OUT.
