

ISABELLA UNDERWOOD to MARY V. OLSON

KNOW ALL MEN BY THESE PRESENTS, That I, Isabella Underwood, unmarried, of lawful age, in consideration of One Dollar and other considerations, to me paid by Mary V. Olson, do hereby REMISE, RELEASE and forever QUITCLAIM unto the said Mary V. Olson, and unto her heirs and assigns, all my rights, title and interest in and to ^{all} that parcel of real estate situate in County of Skamania, State of Washington, to-wit:

Commencing at a point from which the corner of Sections 14, 15, 22, and 23, Township Three North, Range 10 East of W.M. bears North no degrees and 7 minutes East 1335.50 feet distance, said point being identical with the quarter corner of Sections 22 & 23, same Township and Range and marked with an iron pipe; thence South no degrees and 7 minutes West 1335.50 feet to the quarter corner of Sections 22 & 23; thence South no degrees and 7 minutes West 1052.4 feet to meander corner for Sections 22 & 23; thence along the meander line South 52 degrees East 342.20 feet to a point; thence along said line South 84 degrees East 3387.66 feet to the Southeast corner; thence along East line North no degrees and 6 minutes East 2639.30 feet to the Northeast corner; thence along North line 656.13 feet West to the quarter corner of the initial point; said tract containing 38.67 acres, more or less.

Also, Lots 1, 3, 6, 10, 11, 12, 13, 14, 15 and 16 in Block One (1), and Lots 1, 2, 3, 4, 6, 8, 9, and 10 in Block Two (2) of the Town of Underwood, Washington.

Also, Lots 17, 18, and 19 in Block One (1) of the Town of Underwood, Washington.

It is the intention to convey hereby all of grantor's interests in and to that certain property covered by deed of Henry Olson to grantee herein, by deed of quitclaim of date July 30th, 1919, except as to Lots 7, 8 and 9, which grantee has deeded to grantor herein.

TO HAVE AND TO HOLD, the same with all the privileges and appurtenances thereunto belonging to said Mary V. Olson, and to her heirs and assigns forever.
