THIS INDENTURE WITNESSETH, THAT GEORGE H. PRATT, A SINGLE MAN PARTY

OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY A. A. DISBROW, A  
BACHELOR PARTY OF THE SECOND PART, HAS GRANTED, BARGAINED AND SOLD, AND BY THESE  
PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND  
PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED PREMISES, SITUATE,  
LYING AND BEING IN THE COUNTY OF SKAMANIA STATE OF WASHINGTON, TO-WIT:

COMMENCING AT A POINT ON THE WEST LINE OF STRAWBERRY ROAD 300 FEET  
SOUTH OF THE NORTH LINE OF LOT NUMBERED ONE (1) STEVENSON PARK ADDITION  
(ACCORDING TO THE OFFICIAL PLAT THEREOF RECORDED AT PAGE 38 PLAT BOOK A RECORDS  
OF SKAMANIA COUNTY, WASHINGTON) EXTENDED EAST; THENCE WEST 205 FEET, THENCE  
SOUTHEASTERLY TO A POINT 350 FEET SOUTH OF SAID NORTH LINE OF LOT ONE, AND  
185 FEET WEST OF THE WEST LINE OF SAID STRAWBERRY ROAD, THENCE SOUTHEASTERLY  
TO A POINT 400 FEET SOUTH OF SAID NORTH LINE OF SAID LOT ONE, AND 165 FEET WEST  
OF SAID STRAWBERRY ROAD, THENCE SOUTHEASTERLY TO A POINT 450 FEET SOUTH OF  
SAID NORTH LINE OF SAID LOT ONE, AND 132 FEET WEST OF SAID STRAWBERRY ROAD,  
THENCE EAST 132 FEET TO THE WEST LINE OF STRAWBERRY ROAD, THENCE NORTHERLY  
ALONG THE WEST LINE OF SAID STRAWBERRY ROAD (WHICH IS ALSO THE EAST LINE OF SAID  
LOT ONE STEVENSON PARK ADDITION) TO THE PLACE OF BEGINNING.
