E. M. HOUTS TO MONSUETTO TAVELLI ET UX

THE MORTGAGOR, E. M. HOUTS MORTGAGE TO MONSUETTE TAVELLI AND ANNA TAVELLI THE FOLLOWING DESCRIBED REAL ESTATE SITUATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:
