THIS INDENTURE MADE AND ENTERED INTO THIS 1ST DAY OF OCTOBER, 1925, BY AND BETWEEN WAUNA TOLL BRIDGE COMPANY, A CORPORATION DULY ORGANIZED AND EXISTING UNDER THE LAWS OF THE STATE OF WASHINGTON, WITH ITS PRINCIPAL PLACE OF BUSINESS AT WALLA WALLA, WASHINGTON, PARTY OF THE FIRST PART, HEREINAFTER DESIGNATED AS THE MORTGAGOR, AND THE BAKER-BOYER NATIONAL BANK OF WALLA WALLA, AS TRUSTEE, PARTY OF THE SECOND PART, AND HEREINAFTER TERMED THE TRUSTEE, WITNESSETH:
