COME NOW LORENA MAY WALLACE, FAY OLIVE MARBLE AND RAE STAYTON, SURVIVING DAUGHTERS OF J. O. WING, DECEASED, AND RESPECTFULLY SHOW THE COURT:

THAT HERETOFORE THE WILL OF J. O.
