BEEN AGREED UPON TO BE PAID LACY ELLIS WING FOR EXTRAORDINARY SERVICES IN ADDI-TION TO THE SUM PROVIDED BY STATUTE, AMOUNTING TO \$1026.44, AND IT FURTHER APPEARING TO THE COURT THAT HERETOFORE LACY ELLIS WING, LORENA MAY WALLACE, FAY OLIVE MARBLE, AND RAE STAYTON, SURVIVING HEIRS OF J. O. WING, DECEASED, ENTERED INTO AN AGREEMENT WITH MARGARET A, WING, WHEREIN CERTAIN PERSONAL PROPERTY AND REAL PROPERTY WERE CONVEYED TO SAID MARGARET A. WING IN FULL SETTLEMENT OF HER INTER-EST IN AND TO SAID ESTATE, SAID PROPERTY BEING MORE SPECIFICALLY REFERRED TO IN SAID FINAL ACCOUNT, AND IT FURTHER APPEARING TO THE COURT THAT LACY ELLIS WING HAS BY DEED CONVEYED TO LORENA MAY WALLACE, FAY OLIVE MARBLE, AND RAE STAYTON, EACH AN UNDIVIDED ONE-FOURTH INTEREST IN AND 'TO' THE REMAINDER OF SALD REAL PROPERTY BELONGING TO THE ESTATE OF J. AND IT FURTHER APPEARING TO THE COURT THAT SAID ESTATE IS IN CONDITION TO BE CLOSED AND DISTRIBUTED, AND THAT THERE IS NOW IN THE HANDS OF LACY ELLIS WING, EXECUTOR OF THE ESTATE OF J. O. WING, DECEASED, THE SUM OF \$3249.98, OUT OF WHICH IS TO BE, PAID \$5.00 TO THE CLERK OF THIS COURT, \$5.00 TO THE WASHOUGAL TIMES FOR PUBLICATION OF FINAL NOTICE, \$600.00 AS PER STIPULATION FOR EXTRAORDINARY COMPENSATION TO LACY ELLIS WING, \$1026.44 TO LACY ELLIS WING AS PROVIDED BY LAW AS EXECUTOR OF SAID ESTATE, AND THE SUM OF \$1000.00 TO G. EVERT BAKER, ATTORNEY FOR SAID ESTATE, AFTER THE PAYMENT OF SAID SUMS ABOVE SET FORTH, THERE REMAINS IN THE HANDS OF SAID EXECUTOR IN CASH TO BE DISTRIBUTED, IN ADDITION TO THE REAL AND PERSONAL PROPERTY SET FORTH IN SAID PETITION HERE—INBEFORE REFERRED TO THE SUM OF \$613.54.

NOW THEREFORE, IT IS ORDERED ADJUDGED AND DECREED THAT SAID FINAL ACCOUNT OF SAID EXECUTOR, LACY ELLIS WING, BE AND THE SAME IS HEREBY SETTLED, ALLOWED, AND APPROVED AS RENDERED, EXCEPT THE SUM OF \$1200.00 FOR EXTRAORDINARY SERVICES WHICH IS APPROVED IN THE SUM OF \$600.00 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED THAT SAID LACY ELLIS WING, EXECUTOR OF SAID ESTATE OF J. O. WING, DECEASED, BE AND HE IS HEREBY AUTHORIZED AND DIRECTED TO PAY OUT OF THE FUNDS ON HANDS THE SUM OF \$5.00 FINAL CLERK'S FEES, \$5.00 TO THE WASHOUGHL TIMES FOR THE PUBLICATION OF FINAL NOTICE, \$600.00 TO LACY ELLIS WING
