JEMTEGAARD BEING FIRST DULY SWORN SAYS: I AM THE SAME PERSON NAMED IN THAT CERTAIN ASSIGNMENT OF CONTRACT FOR THE WEST QUARTER OF THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 17 TP 3 N R 5 E. W.M. AS RECORDED AT PAGE 220 OF BOOK 0 OF DEEDS RECORDS OF SKAMANIA COUNTY WASH.; THAT AT THE DATE OF THE SAID ASSIGNMENT, TO-WIT JAN 27TH 1913, GERTRUDE JEMTEGAARD WAS MY WIFE;

THAT I WAS WELL AND PERSONALLY ACQUAINTED WITH H. M. BARNES AT THE DATE OF THE DELIVERY THEREOF, AND THE INTEREST DUE UPON THE PRINCIPAL DECEMBER 31 1911, WHICH INTEREST WAS PAID BY WORK DONE FOR THE SAID W. B. BARNES BY THE SAID H.M.NYGAARD; THAT THE ASSIGNMENT OF THE SAID CONTRACT TO ME WAS MADE IN GOOD FAITH, AND I TOOK THEREUNDER ALL INTEREST OF THE SAID H. M.
