

D. C. LATOURETTE ET UX TO STEVENSON EVANGELICAL LUTHERAN CHURCH

KNOW ALL MEN BY THESE PRESENTS, THAT, WHEREAS, THE STEVENSON EVANGELICAL LUTHERAN CHURCH, A CORPORATION, HAS THIS DAY PURCHASED FROM D. C. LATOURETTE AND E. S. LATOURETTE, HIS WIFE, THE WEST-HALF OF LOTS SIX AND SEVEN IN BLOCK ONE OF UPPER CASCADED ADDITION TO THE TOWN OF STEVENSON, WASH.;

AND WHEREAS, IT IS DESIRED TO INCLUDE IN THE SAID DEED ALSO THE EAST-HALF OF THE SAID LOTS SIX AND SEVEN BLOCK ONE UPPER CASCADES ADDITION;

AND WHEREAS, THE SAID EAST-HALF OF SAID LOTS SIX AND SEVEN BLOCK ONE WAS HERETOFORE DEEDED BY THE SAID D. C. LATOURETTE AND E. S. LATOURETTE, HIS WIFE, TO THE LUTHERAN CHURCH OF STEVENSON AND HOME VALLEY, WASH., WHICH HAS SINCE BECOME INCORPORATED UNDER THE NAME OF STEVENSON EVAGELICAL LUTHERAN CHURCH;

NOW, THEREFORE, IN CONSIDERATION OF THE EXECUTION OF THE SAID DEED TO LOTS SIX AND SEVEN BLOCK ONE UPPER CASCADES ADDITION TO THE TOWN OF STEVENSON, TO THE STEVENSON EVANGELICAL LUTHERAN CHURCH, AS AFORESAID, AND OF THE SUM OF ONE DOLLAR, THE SAID LUTHERAN CHURCH OF STEVENSON AND HOME VALLEY, WASH., PARTY OF THE FIRST PART, DOES HEREBY GRANT, BARGAIN, SELL AND QUITCLAIM UNTO D. C. LATOURETTE AND E. S. LATOURETTE, HIS WIFE, PARTY OF THE SECOND PART, THE FOLLOWING REAL PROPERTY IN SKANANIA COUNTY, WASH., TO-WIT:

THE EAST-HALF OF LOTS SIX AND SEVEN IN BLOCK ONE (1), UPPER CASCADES ADDITION TO THE TOWN OF STEVENSON, WASH., ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE WITH THE COUNTY AUDITOR OF SKAMANIA COUNTY, WASH., AND RECORDED IN THE BOOKS OF SAID COUNTY AND STATE, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID LOT SEVEN, WHICH IS ALSO THE SOUTHEAST CORNER OF AFORESAID BLOCK ONE (1), THENCE NORTH $0^{\circ} 38' E$ 62.7 FEET TO THE NORTHEAST CORNER OF SAID LOT SIX (6); THENCE NORTH $88^{\circ} 12' W$ ALONG NORTH LINE OF AFORESAID LOT SIX (6) 52.3 FEET; THENCE SOUTH $0^{\circ} 38' W$ 78.1 FEET TO THE SOUTHERLY LINE OF SAID BLOCK ONE (1); THENCE N $66^{\circ} 52' E$. 53.8 FEET TO PLACE OF BEGINNING.
