NOW, THEREFORE, THE COUNTY OF SKAMANIA, THE PARTY OF THE FIRST PART, IN CONSIDERATION OF THE SUM OF ONE DOLLAR (\$1.00) DULY PAID TO THE PARTY OF THE FIRST PART BY THE PARTY OF THE SECOND PART, AND OF OTHER VALUABLE CONSIDERATIONS, THE RECEIPT WHEREOF IS HEREBY CONFESSED AND ACKNOWLEDGED, DOES HEREBY REMISE, RELEASE, QUITCLAIM AND CONVEY UNTO THE SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY, THE PARTY OF THE SECOND PART, ITS SUCCESSORS AND ASSIGNS, ALL RIGHT, TITLE AND INTEREST OF EVERY NATURE WHATSOEVER NOW HELD BY THE PARTY OF THE FIRST PART HERETO IN AND TO LOTS 1 AND 2 OF SECTION 34 IN TOWNSHIP 3 NORTH OF RANGE 9 EAST OF THE WILLAMETTE MERIDIAN IN SKAMANIA COUNTY, WASHINGTON, VESTED IN IT BY SAID DECREE OF CONDEMNATION AND APPROPRIATION SO ENTERED BY THE SUPERIOR COURT OF SKAMANIA COUNTY, WASHINGTON, ON JUNE 17, 1915, AND ALL RIGHTS OF WAY IN, TO, OVER OR ACROSS ANY OF THE PREMISES OF THE PARTY OF THE SECOND PART ACQUIRED BY THE PARTY OF THE FIRST PART OVER THE LANDS AND PREMISES OF THE PARTY OF THE SECOND PART SITUATED IN SAID LOTS 1 AND 2 IN SAID SECTION 34.
