THIS INDENTURE, MADE AND ENTERED INTO THIS 16TH DAY OF DECEMBER, 1925, BETWEEN WEST COAST POWER COMPANY, A CORPORATION ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF DELAWARE, WITH ITS PRINCIPAL OFFICE AT THE CITY OF WILMINGTON IN SAID STATE, PARTY OF THE FIRST PART (HEREINAFTER FOR CONVENIENCE TERMED THE "COMPANY") AND CENTRAL TRUST COMPANY OF ILLINOIS, A CORPORATION ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF ILLINOIS, WITH ITS PRINCIPAL OFFICE AND POST-OFFICE ADDRESS AT NO. 125 WEST MONROE STREET, IN THE CITY OF CHICAGO, ILLINOIS, AND AKSEL K. BODHOLDT, WHOSE POST-OFFICE ADDRESS IS NO. 125 WEST MONROE STREET IN THE CITY OF CHICAGO, ILLINOIS, PARTIES OF THE SECOND PART (HEREINAFTER FOR CONVENIENCE TERMED THE "TRUSTEES", THE CENTRAL TRUST COMPANY OF ILLINOIS, WHEREVER HEREINAFTER SEPARATELY REFERRED TO, BEING TERMED THE "TRUST COMPANY") WITNESSETH:

THAT WHEREAS, THE COMPANY AND THE TRUSTEES HERETOFORE ENTERED INTO A CERTAIN INDENTURE (HEREINAFTER CALLED THE "ORIGINAL INDENTURE") BEARING DATE AS OF THE FIRST DAY OF DECEMBER, A.D. 1924), IN AND BY WHICH THE COMPANY CONVEYED TO THE TRUSTEES ALL OF ITS PROPERTIES AND FRANCHISES THEN OWNED OR TO BE THEREAFTER ACQUIRED (EXCEPT MERCHANDISE HELD FOR THE PURPOSE OF SALE TO ITS CUSTOMERS) TO SECURE AN ISSUE OF BONDS OF SAID COMPANY WITHOUT LIMIT AS TO AGGREGATE PRINCIPAL AMOUNT, OF WHICH ISSUE THERE HAVE BEEN ISSUED AND ARE NOW OUTSTANDING BONDS TO THE AGGREGATE PRINCIPAL AMOUNT OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000.00), WHICH SAID ORIGINAL INDENTURE WAS DULY FILED FOR RECORD IN THE OFFICE OF THE COUNTY CLERK AND EX-OFFICIO RECORDER OF CONVEYANCES OF THE COUNTY OF CLATSOP, OREGON, ON JANUARY 8, 1925, AND RECORDED IN BOOK 59 ON PAGE 70 OF LAND COUNTY MORTGAGE RECORDS AND INDEXED IN REAL ESTATE AND CHATTEL MORTGAGE INDEXES AND DULY FILED FOR RECORD IN THE OFFICE OF THE COUNTY CLERK OF THE COUNTY OF TILLAMOOK, OREGON, ON JANUARY 7, 1925, AND RECORDED IN BOOK 15, PAGES 1 TO 43 OF THE RECORD OF MORTGAGES OF SAID COUNTY AND INDEXED IN CHATTEL MORTGAGE RECORD INDEX BOOK 2 OF SAID COUNTY, AND DULY FILED FOR RECORD IN THE OFFICE OF THE COUNTY CLERK OF LINCOLN COUNTY, OREGON, ON JANUARY 5, 1925, AND RECORDED IN BOOK 25 ON PAGE 555, RECORD OF MORTGAGES, AND INDEXED IN CHATTEL MORTGAGE RECORDS OF SAID COUNTY AND DULY FILED FOR RECORD IN THE OFFICE OF THE COUNTY CLERK AND EX-OFFICIO RECORDER OF CONVEYANCES OF DOUGLAS COUNTY, OREGON, ON JANUARY 6, 1925, AND RECORDED AT PAGE 110 OF VOLUME 41 OF MORTGAGE RECORDS OF SAID COUNTY AND INDEXED IN THE CHATTEL MORTGAGE INDEXES OF SAID COUNTY, AND WAS DULY FILED FOR RECORD IN THE OFFICE OF THE AUDITOR OF MASON COUNTY, WASHINGTON, ON JANUARY 5, 1925, AND RECORDED IN VOLUME 44 OF MORTGAGES, PAGE 111, AND WAS DULY FILED FOR RECORD AS A CHATTEL MORTGAGE IN THE OFFICE OF THE AUDITOR OF MASON COUNTY, WASHINGTON, ON JANUARY 5, 1925,
