

TOWN OF GARDINER, DOUGLAS COUNTY, OREGON (BEING THE PLANT AND SYSTEM ACQUIRED BY THE COMPANY BY INSTRUMENT OF CONVEYANCE EXECUTED BY GARDINER LIGHT & POWER COMPANY, AN OREGON CORPORATION TO THE COMPANY DATED APRIL 7, 1925, AND RECORDED IN THE OFFICE OF THE RECORDER OF CONVEYANCES OF DOUGLAS COUNTY, OREGON AS DOCUMENT NO. 62033 IN VOLUME 87, PAGE 256 OF DEED RECORDS OF SAID COUNTY) AND HYDRO-ELECTRIC PLANT AND ELECTRIC DISTRIBUTING SYSTEM OF THE COMPANY IN THE TOWN OF CASCADE LOCKS, HOOD RIVER COUNTY, OREGON AND THE ELECTRIC DISTRIBUTING SYSTEM OF THE COMPANY IN THE TOWN OF STEVENSON, SKAMANIA COUNTY, WASHINGTON, AND THEIR VICINITIES, (BEING THE PLANT AND DISTRIBUTING SYSTEMS ACQUIRED BY THE COMPANY BY A CERTAIN INSTRUMENT OF CONVEYANCE EXECUTED BY THE SKAMANIA LIGHT AND POWER COMPANY, A CORPORATION, TO THE COMPANY, TO BE RECORDED IN SKAMANIA COUNTY, WASHINGTON, AND HOOD RIVER COUNTY, OREGON), AND ANY ELECTRIC GENERATING PLANTS AND ELECTRIC DISTRIBUTING SYSTEMS HEREAFTER CONSTRUCTED OR ACQUIRED BY THE COMPANY IN SAID COUNTIES OR ANY OF THEM, AND ANY ADDITIONS TO AND/OR EXTENSIONS OF ANY SUCH EXISTING OR FUTURE ELECTRIC GENERATING PLANTS AND/OR ELECTRIC DISTRIBUTING SYSTEMS, TOGETHER WITH THE ENGINES, BOILERS, GENERATORS, TURBINES, POLE LINES, POLES, WIRES, CROSS ARMS, INSULATORS, TRANSFORMERS, METERS, BUILDINGS, ERECTIONS, STRUCTURES, STATIONS, SUB-STATIONS, POWERHOUSES, DAMS, WATER WHEELS, SLUCES, RACES, FOREBAYS, GATES, POWER PRODUCING AND POWER TRANSMITTING EQUIPMENT, CABLES, CONDUITS, TOOLS, INSTRUMENTS, APPARATUS, APPLIANCES, MACHINERY FACILITIES AND OTHER PROPERTY USED OR PROVIDED FOR USE IN THE CONSTRUCTION, REPAIR, MAINTENANCE AND/OR OPERATION THEREOF, BOTH THAT NOW OWNED AND THAT WHICH MAY HEREAFTER BE ACQUIRED BY THE COMPANY, AND TOGETHER ALSO WITH ALL THE RIGHTS, PRIVILEGES, FRANCHISES, EASEMENTS, LICENSES, ORDINANCES, RIGHTS-OF-WAY, FLOWAGE-RIGHTS, GRANTS, LIBERTIES, IMMUNITIES AND PERMITS OF THE COMPANY, HOWSOEVER CONFERRED OR ACQUIRED, AND WHETHER NOW OWNED OR HEREAFTER TO BE ACQUIRED, WITH RESPECT TO THE CONSTRUCTION, MAINTENANCE, REPAIR AND/OR OPERATION OF SAID PLANTS AND SYSTEMS, AND EACH OF THEM, AND ANY ADDITIONS THERETO AND EXTENSIONS THEREOF, INCLUDING PARTICULARLY, BUT NOT EXCLUSIVELY, THE RIGHTS, PRIVILEGES, EASEMENTS AND BENEFITS CONFERRED BY THE FOLLOWING ORDINANCES, FRANCHISES AND PERMITS, TITLE TO ALL WHEREOF IS NOW VESTED IN THE COMPANY, TO-WIT:

1. FRANCHISE GRANTED BY ORDINANCE No.204 OF THE CITY OF BURNS, OREGON TO BURNS POWER COMPANY AND ASSIGNED BY SAID BURNS POWER COMPANY TO THE WEST COAST POWER COMPANY.
2. FRANCHISE GRANTED TO GARDINER LIGHT & POWER COMPANY BY COUNTY COURT OF COUNTY OF DOUGLAS BY AN ORDER MADE AND ENTERED ON THE 4TH DAY OF DECEMBER, 1924.
3. RIGHTS AND FRANCHISES GRANTED TO GARDINER LIGHT & POWER COMPANY BY STATE HIGHWAY COMMISSION OF THE STATE OF OREGON TO OPERATE AND MAINTAIN ELECTRIC LIGHT AND POWER LINES UPON CERTAIN HIGHWAYS WITHIN THE COUNTY OF DOUGLAS AND STATE OF OREGON.
4. ORDINANCE No. 29 GRANTED BY TOWN COUNCIL OF TOWN OF STEVENSON, WASHINGTON, NOVEMBER 10, 1908, GRANTING FRANCHISE TO SAM SAMSON AND A. L. ORSEN, THEIR HEIRS, ADMINISTRATORS, EXECUTORS AND ASSIGNS.
5. FRANCHISE GRANTED BY BOARD OF COUNTY COMMISSIONERS OF SKAMANIA COUNTY, WASHINGTON, JANUARY 5, 1909, TO SKAMANIA LIGHT AND POWER COMPANY.
6. A PERMIT GRANTED BY THE COMMISSIONERS OF HOOD RIVER COUNTY, OREGON, TO COLUMBIA RIVER LIGHT AND POWER COMPANY JUNE 5, 1911.
