

COMMENCING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF THE
SOUTHWEST QUARTER OF SECTION ELEVEN (11), TOWNSHIP THREE (3) NORTH OF RANGE NINE
(9) EAST OF THE WILLAMETTE MERIDIAN, THENCE EAST 213.3 FEET; THENCE SOUTH 39DEG-
REES 53' EAST 228 FEET; THENCE SOUTH 51 DEGREES 00' EAST, 400 FEET; THENCE SOUTH
ON DIVISION LINE OF THE FORTY TO CENTER LINE OF QUARTER SECTION; THENCE WEST
665 FEET; THENCE NORTH ON DIVISION LINE TO PLACE OF BEGINNING, CONTAINING 17.03
