IN THE NAME OF GOD--AMEN.

KNOW ALL MEN, THAT I, GEORGE GREEN CITY OF PORTLAND OF MULTNOMAH CO IN THE STATE OF OREGON, OF THE AGE OF 59 YEARS, BEING OF SOUND AND DISPOSING MIND AND MEMORY, AND NOT ACTING UNDER DURESS, MENACE, FRAUD OR UNDUE INFLUENCE OF ANY PERSON WHOMSOEVER, DO MAKE, PUBLISH AND DECLARE THIS MY LAST WILL AND TESTAMENT IN MANNER AND FORM FOLLOWING, TO-WIT:

FIRST. IT IS MY WILL, AND I DO ORDER, THAT ALL MY JUST DEBTS AND FUNERAL EXPENSES BE DULY PAID-AND SATISFIED AS SOON AS CONVENIENTLY CAN BE DONE AFTER MY DECEASE.

SECOND. I GIVE AND BEQUEATH UNTO ESTHER GREEN MY WIFE ALL REAL AND PERSONAL PROPERTY OWNED NOW OR THAT I MAY ACQUIRE, TO BE USED BY HER DURING HER LIFE AND WHAT IS LEFT AFTER MY WIFES DEATH I BEQUEATH TO MY SON P. W. GREEN. SHOULD MY SONS DEATH OCCUR BEFORE THAT OF MY WIFE, THEN WHAT PROPERTY REVERTS TO HIM AS SPECIFIED IN THIS WILL SHALL GO TO HIS CHILDREN SHOULD THERE BE ANY TO BE DIVIDED EQUALLY AMONG THEM AFTER THEY ARE TWENTY-ONE YEARS OF AGE. THEIR MOTHERS SHALL NOT HAVE THE HANDLING OR DISPOSING OF THIS PROPERTY.

IN CASE MY SON HAS NO CHILDREN THEN WHAT PROPERTY WOULD GO TO THEM ACCORDING TO THE TERMS OF THIS WILL, SHALL BE DIVIDED EQUALLY BETWEEN MY WIFES TWO SISTERS MARGARET AND NORAH MAHON WHO ARE NOW RESIDING AT STREAMSTOWN CO. WESTMEATH IRELAND.

AND, LASTLY, I NOMINATE, CONSTITUTE AND APPOINT P. W. GREEN MY SON WITHOUT BONDS AND WITH THE UNDERSTANDING THAT HIS SERVICES SHALL BE GRATIS TO BE THE EXECUTOR OF THIS, MY LAST WILL, HEREBY REVOKING ALL OTHER WILLS, LEGACIES AND BEQUESTS BY ME HERETOFORE MADE, AND DECLARING THIS, AND NO OTHER, TO BE MY LAST WILL AND TESTAMENT.
