IT APPEARING TO THE COURT THAT SAID DECEDENT DIED ON OR ABOUT THE ... DAY OF AUGUST, 1918, IN THE COUNTY OF MULTNOMAH AND STATE OF OREGON; THAT AT THE TIME OF HIS DEATH HE WAS A RESIDENT AND INHABITANT OF SAID COUNTY AND STATE; THAT HE LEFT ESTATE IN THE COUNTY OF LINCOLN AND STATE OF OREGON CONSISTING OF REAL PROPERTY OF THE PROBABLE VALUE OF \$2,000; THAT THE NEXT OF KIN AND HEIRS AT LAW OF THE SAID DECEDENT ARE ESTHER GREEN, THE PETITIONER, HIS WIDOW, AND HIS SON, P.
