W. A. WENDORF ET UX TO FRANCES BENEDICT

WHEREAS A SUIT HAS BEEN INSTITUTED IN THE SUPERIOR COURT OF THE STATE OF WASHINGTON, FOR THE COUNTY OF SKAMANIA BY FRANCES BENEDICT, PLAINTIFF, .. AGAINST W. A. WENDORF AND HELEN L. WENDORF, HIS WIFE, TO QUIET TITLE TO AND ESTABLISH HER RIGHT TO THE POSSESSION OF ONE CERTAIN SPRING OF WATER CLAIMED BY THE SAID PLAINTIFF TO BE LOCATED ON LAND IN THE SAID SKAMANIA COUNTY BY HER DESCRIBED AS FOLLOWS:

THE NORTHEAST ONE-FOURTH (NE $\frac{1}{4}$ ) OF THE SOUTHWEST ONE-FOURTH (SW $\frac{1}{4}$ ) OF THE NORTHEAST ONE-FOURTH (NE $\frac{1}{4}$ ) OF SECTION 16, TOWNSHIP 3 NORTH, OF RANGE 10 EAST OF THE WILLAMETTE MERIDIAN.

NOW THEREFORE, IN CONSIDERATION OF THE DISMISSAL OF THE SAID SUIT WITHOUT COSTS TO THE SAID DEFENDANTS, AND AS A COMPROMISE SETTLEMENT OF THE ISSUES INVOLVED IN THE SAID SUIT, THE SAID DEFENDANTS THEREIN W. A. WENDORF AND HELEN L. WENDORF, HIS WIFE, DO HEREBY WAIVE AND RELEASE TO THE SAID FRANCES BENEDICT ALL OF THEIR RIGHT, TITLE, CLAIM, INTEREST AND EQUITY, OF EVERY NATURE AND KIND, IN AND TO THE SAID SPRING OF WATER LOCATED AS AFORESAID, AND THEIR ALLEGED RIGHT TO TAKE WATER THEREFROM ARISING OUT OF AN ALLEGED LOCATION OF WATER RIGHT FILED BY THEM THEREON AND BY PRESCRIPTION.
