KNOW ALL MEN BY THESE PRESENTS THAT WHEREAS VANCOUVER NATIONAL BANK, A BANKING CORPORATION, DULY ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE UNITED STATES OF AMERICA, WITH PLACE OF BUSINESS LOCATED AT VANCOUVER, STATE OF WASHINGTON, HEREINAFTER CALLED THE PARTY OF THE FIRST PART, IS THE OWNER AND HOLDER OF THAT CERTAIN JUDGMENT HERETOFORE ENTERED ON THE 28TH DAY OF JAN'Y, 1915 IN THE SUPERIOR COURT OF THE STATE OF WASHINGTON FOR THE COUNTY OF SKAMANIA IN CASE #1467 ENTITLED VANCOUVER NATIONAL BANK VS. CURTISS, OF GRAND DALLES, WASHINGTON, PARTY OF THE SECOND PART, DOES BY THESE PRESENTS, REMISE, RELEASE AND FOREVER QUITCLAIM UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, ALL ITS RIGHT, TITLE AND INTEREST IN AND TO THAT CERTAIN TRACT OF LAND, LOCATED, LYING AND BEING IN THE COUNTY OF SKAMANIA STATE OF WASHINGTON, DESCRIBED AS:

LOT THREE (3) IN BLOCK SIX (6) OF THE MANZANOLA ORCHARD AND LAND COMPANY TRACT, OTHERWISE DESCRIBED AS THE SOUTHWEST QUARTER OF SOUTHWEST QUARTER OF NORTHEAST QUARTER (SW $\frac{1}{4}$ OF SW $\frac{1}{4}$ OF NE $\frac{1}{4}$) OF SECTION TEN (10) TOWNSHIP THREE (3) NORTH, RANGE NINE (9) EAST, WILLAMETTE MERIDIAN.
