SUPPLEMENTAL INDENTURE, DATED AS OF MAY 1, 1926, BETWEEN THE PORTLAND ELECTRIC POWER COMPANY, A CORPORATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE STATE OF OREGON (HEREINAFTER CALLED THE "COMPANY"), PARTY OF THE FIRST PART, AND THE NATIONAL CITY BANK OF NEW YORK, A CORPORATION ORGANIZED AND EXISTING AS A NATIONAL BANKING ASSOCIATION UNDER THE LAWS OF THE UNITED STATES OF AMERICA, HAVING ITS HEAD OFFICE AND PRINCIPAL PLACE OF BUSINESS AT NO. 55 WALL STREET, IN THE BOROUGH OF MANHATTAN, CITY AND STATE OF NEW YORK, AS TRUSTEE UNDER THE MORTGAGE HEREINAFTER REFERRED TO (HEREINAFTER CALLED THE "TRUSTEE"), PARTY OF THE SECOND PART.

WHEREAS, THE COMPANY HERETOFORE EXECUTED IN ITS THEN CORPORATE NAME, "PORTLAND RAILWAY, LIGHT AND POWER COMPANY", AND DELIVERED TO THE TRUSTEE A CERTAIN MORTGAGE OR DEED OF TRUST, DATED APRIL 30, 1921, TO SECURE AN ISSUE OF FIRST LIEN AND REFUNDING MORTGAGE GOLD BONDS OF THE COMPANY, ISSUED AND TO BE ISSUED, IN SERIES, FROM TIME TO TIME, IN THE MANNER AND SUBJECT TO THE CONDITIONS SET FORTH IN THE
