THIS INDENTURE, MADE THE 21ST DAY OF MAY, 1917, BETWEEN GEORGE GOOD AND ELIZABETH C. GOOD, HIS WIFE, OF THE COUNTY OF MULTNOMAH, STATE OF OREGON, PARTIES OF THE FIRST PART, AND HENRY J. BIDDLE, OF CLARKE COUNTY, WASHINGTON, PARTY OF THE SECOND PART.

WITNESSETH: THAT FOR AND IN CONSIDERATION OF ONE (\$1.00) DOLLAR IN HAND PAID, RECEIPT WHEREOF IS HEREBY DULY ACKNOWLEDGED, THE PARTIES OF THE FIRST PART DO HEREBY GRANT, BARGAIN, SELL, CONVEY AND CONFIRM UNTO SAID PARTY OF THE SECOND PART AN EASEMENT AND RIGHT OF WAY TEN (10) FEET IN WIDTH OVER THE FOLLOWING PARCEL OF LAND SITUATE IN SKAMANIA COUNTY, WASHINGTON, PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:
