THIS INDENTURE WITNESSETH, THAT SKAMANIA COOPERATIVE TELEPHONE ASSOCIATION, A CORPORATION, DULY INCORPORATED, ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF WASHINGTON, WITH ITS PRINCIPAL OFFICE AT STEVENSON, WASHINGTON, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN (\$10.00) DOLLARS AND OTHER VALUABLE CONSIDERATIONS IN LAWFUL MONEY OF THE UNITED STATES, TO IT PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS BARGAINED, SOLD, AND CONVEYED AND BY THESE PRESENTS DOES BARGAIN, SELL AND CONVEY UNTO E. L. MOSTERT, PARTY OF THE SECOND PART, ALL OF THE FOLLOWING DESCRIBED REAL ESTATE, SITUATE AND BEING IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON, TO-WIT:

LOTS THIRTY-ONE (31) AND THIRTY-TWO (32) IN BLOCK TWO (2) OF THE TOWN OF STEVENSON.

TOGETHER WITH TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANY WISE APPERTAINING.

TO HAVE AND TO HOLD THE SAME WITH THE APPURTENANCES UNTO THE SAID E. L. MOSTERT, HIS HEIRS AND ASSIGNS FOREVER; AND THE SAID SKAMANIA COOPERATIVE TELEPHONE ASSOCIATION, PARTY OF THE FIRST PART, FOR ITSELF AND FOR ITS SUCCESSORS OR ASSIGNS, DOES HEREBY COVENANT TO AND WITH THE SAID PARTY OF THE SECOND PART, HIS HEIRS, AND ASSIGNS, THAT IT IS THE OWNER IN FEE SIMPLE OF SAID PREMISES, AND THAT THEY ARE FREE FROM ALL INCUMBRANCES WHATSOEVER AND THAT THEY WILL WARRANT AND DEFEND THE TITLE THERETO AGAINST ALL LAWFUL CLAIMS WHATSOEVER.

IN WITNESS WHEREOF, SKAMANIA COOPERATIVE TELEPHONE ASSOCIATION, PARTY OF THE FIRST PART, HAS CAUSED ITS LAWFUL CORPORATE SEAL TO BE HEREUNTO AFFIXED AND ITS NAME TO BE HERETO SUBSCRIBED BY ITS PRESIDENT AND SECRETARY THIS 24TH DAY OF MARCH, 1920.
