THIS INDENTURE MADE AND ENTERED INTO THIS 26TH DAY OF JULY, A. D. 1926, BY AND BETWEEN CENTRAL TRUST COMPANY OF ILLINOIS, A CORPORATION ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF ILLINOIS AND HAVING ITS OFFICE AT 125 WEST MONROE STREET, IN THE CITY OF CHICAGO, ILLINOIS, AND AKSEL K. BODHOLDT, WHOSE POSTOFFICE ADDRESS IS 125 WEST MONROE STREET, IN THE CITY OF CHICAGO, ILLINOIS, AS TRUSTEES, PARTIES OF THE FIRST PART, AND WEST COAST POWER COMPANY, A CORPORATION ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF DELAWARE, PARTY OF THE SECOND PART, WITNESSETH: THAT

WHEREAS, THE PARTY OF THE SECOND PART FOR THE PURPOSE OF SECURING AN ISSUE OF FIRST MORTGAGE GOLD BONDS OF WHICH FIVE HUNDRED AND TWENTY FIVE THOUSAND DOLLARS (\$525,000.00) PAR VALUE FIRST MORTGAGE SIX AND ONE-HALF PER CENT SERIES "A" GOLD BONDS WERE ISSUED, HERETOFORE MADE, EXECUTED, ACKNOWLEDGED AND DELIVERED TO THE SAID PARTIES OF THE FIRST PART AS TRUSTEES, ITS CERTAIN TRUST INDENTURE DATED AS OF THE 1ST DAY OF DECEMBER, A. D. 1924 BUT ACTUALLY EXECUTED AND ENTERED INTO THE 29TH DAY OF DECEMBER, A. D. 1924, COVERING AND CONVEYING ALL OF THE PROPERTY AND FRANCHISES OWNED BY SAID PARTY OF THE SECOND PART AT THE TIME OF THE EXECUTION OF SAID TRUST INDENTURE OR TO BE THEREAFTER ACQUIRED BY IT, WHICH SAID TRUST INDENTURE WAS DULY FILED FOR RECORD AS FOLLOWS:
