

BOUNDARY LINE OF THE DIVERTED CHANNEL OF SAID FALL CREEK TO A POINT THAT IS 150 FEET SOUTH OF THE SOUTH BOUNDARY LINE OF THE NEW COLUMBIA RIVER HIGHWAY; THENCE WEST 50 FEET, MORE OR LESS, TO AN INTERSECTION WITH THE EAST BOUNDARY OF THE OLD COUNTY ROAD; THENCE IN A SOUTHERLY DIRECTION, FOLLOWING SAID EAST BOUNDARY 250 FEET, MORE OR LESS, TO THE POINT OF BEGINNING. ALSO A RIGHT-OF-WAY TWELVE FEET WIDE, AND THE RIGHT TO BUILD, ERECT AND MAINTAIN A FLUME, DITCH, OR PIPE LINE FROM THE SAID PREMISES ABOVE DESCRIBED, OVER AND ACROSS THE LANDS OF LESSOR, BEING A PART OF THE NORTH HALF OF THE E. G. BRYANT D. L. C. AND PART OF LOT FOUR (4), OF SECTION EIGHT (8), OF SAID TOWNSHIP AND RANGE; TOGETHER WITH THE RIGHT TO DIVERT THE WATER OF SAID FALL CREEK, AND TO FLUME OR PIPE THE SAME OVER SAID LANDS, AS ABOVE SET FORTH, AND THE RIGHT OF ACCESS TO THE SAME AT A REASONABLY CONVENIENT PLACE ACROSS THE LAND OF THE LESSOR; SUBJECT, HOWEVER, TO ALL RIGHTS AND PRIVILEGES HERETOFORE GRANTED TO SILVO GRAHAM AND J. T. GRAHAM, THEIR HEIRS AND ASSIGNS, RESERVING, HOWEVER, TO SAID LESSOR, THE RIGHT AND PRIVILEGE OF TAPPING SAID DITCH, FLUME, OR PIPE LINE, OR DAM, WITH A 2 INCH PIPE AND USING WATER THEREFROM AT SUCH A POINT AT ANY TIME THE SAID LESSOR, HER HEIRS OR ASSIGNS, MAY DESIRE SO TO DO; ALSO RESERVING A RIGHT-OF-WAY 30 FEET WIDE, OVER AND ACROSS SAID FLUME, DITCH OR PIPE LINE, AT SUCH PLACE AS LESSORS MAY SEE FIT, TO BE USED IN SUCH WAY AS NOT TO INTERFERE WITH THE USE OF SAID FLUME, DITCH OR PIPE LINE.
