(G) ALL WATER RIGHTS IN THE NASELLE RIVER, PACIFIC COUNTY, WASHINGTON, AS APPLIED FOR AND GRANTED OR HEREAFTER TO BE GRANTED PURSUANT TO THE APPLICATION OF F. R. NETTLETON, AND AMENDED APPLICATION OF SAID F. R. NETTLETON, FILED IN THE DIVISION OF HYDRAULICS OF THE STATE OF WASHINGTON APRIL 8, 1921, BEING APPLICATION No. 611.

CLAUSE THIRD.

ALL AND SINGULAR THE FRANCHISES, PROPERTY AND ASSETS OF EVERY KIND, CHARACTER AND DESCRIPTION, AND WHERESOEVER SITUATE (OTHER THAN PROPERTY OF THE CHARACTER DEFINED AS "EXCEPTED PROPERTY") FORMERLY BELONGING TO ILLWACO LIGHT & POWER COMPANY, A WASHINGTON CORPORATION, AND CONVEYED TO THE COMPANY BY DEED DATED JULY 19, 1926, FROM SAID ILLWACO LIGHT & POWER COMPANY, INCLUDING THE FOLLOWING DESCRIBED PROPERTY AND FRANCHISES:

1. ALL OF THE FOLLOWING DESCRIBED LOTS, PIECES OR PARCELS OF LAND, TOGETHER WITH ALL ELECTRIC WORKS, HYDRO-ELECTRIC WORKS, POWER HOUSES, DISTRIBUTING SYSTEMS, BUILDINGS, STRUCTURES, ERECTIONS AND IMPROVEMENTS LOCATED ON ANY OR ANY PART THEREOF, WITH THEIR FIXTURES AND ALL OF THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES APPERTAINING AND BELONGING THERETO, ALL OF SAID LOTS, PIECES OR PARCELS OF LAND BEING LOCATED IN PACIFIC COUNTY, WASHINGTON, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

(A) LOT NUMBERED FIVE (5) IN BLOCK NUMBERED TEN (10) OF THE TOWN OF ILLWACO, PACIFIC COUNTY, WASHINGTON, ACCORDING TO THE RECORDED PLAT THEREOF.

(B) BEGINNING AT A POINT ON THE NORTH LINE OF BLOCK TWELVE (12) OF THE TOWN OF ILLWACO FIFTY (50) FEET WEST FROM THE NORTHEAST CORNER OF SAID BLOCK TWELVE (12) AND RUNNING THENCE SOUTH AND PARALLEL WITH THE EAST LINE OF SAID BLOCK FIFTY (50) FEET; THENCE WEST AND PARALLEL WITH THE NORTH LINE OF SAID BLOCK FIFTY (50) FEET; THENCE NORTH AND PARALLEL WITH THE EAST LINE OF SAID BLOCK FIFTY (50) FEET TO THE NORTH LINE OF SAID BLOCK; THENCE EAST FIFTY (50) FEET TO THE PLACE OF BEGINNING, BEING A PART OF LOTS TWELVE (12) AND THIRTEEN (13) OF SAID BLOCK TWELVE (12) OF THE TOWN OF ILLWACO, PACIFIC COUNTY, STATE OF WASHINGTON, ACCORDING TO THE PLAT THEREOF ON RECORD IN THE OFFICE OF THE AUDITOR OF SAID COUNTY AND STATE.

II.

ALL THE FOLLOWING DESCRIBED RIGHTS, FRANCHISES, LICENSES, PERMITS AND BENEFITS, THE TITLE TO ALL WHEREOF IS NOW VESTED IN THE COMPANY:

(A) FRANCHISE GRANTED BY THE TOWN OF ILLWACO TO THE ILLWACO LIGHT & POWER COMPANY, BY ORDINANCE No. 174.

(B) FRANCHISE GRANTED JULY 7, 1922 BY THE BOARD OF COUNTY COMMISSIONERS OF PACIFIC COUNTY, WASHINGTON, TO ILLWACO LIGHT & POWER COMPANY.

(C) FRANCHISE GRANTED BY THE TOWN OF LONG BEACH TO THE ILLWACO LIGHT & POWER COMPANY BY ORDINANCE No. 41.
