KNOW ALL MEN BY THESE PRESENTS, THAT I, GLENN C. CORLIE, A SINGLE
MAN OF UNDERWOOD, STATE OF WASHINGTON, IN CONSIDERATION OF ONE DOLLAR AND OTHER
CONSIDERATIONS TO ME PAID BY A. A. AUSPLUND OF PORTLAND STATE OF OREGON, HAVE
BARGAINED AND SOLD, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY
UNTO SAID A. A. AUSPLUND AND UNTO HIS HEIRS AND ASSIGNS, ALL THE FOLLOWING
BOUNDED AND DESCRIBED REAL PROPERTY, SITUATED IN THE COUNTY OF SKAMANIA AND
STATE OF WASHINGTON: TO -WIT:

BEGINNING AT A POINT EIGHT (8) RODS WEST OF THE SOUTHEAST CORNER OF
THE NORTHWEST QUARTER OF SECTION NINETEEN (19) TWP THREE (3) NORTH, RANGE TEN
(10) EAST OF WILLAMETTE MERIDIAN RUNNING WESTERLY FORTY-EIGHT RODS MORE OR LESS
TO THE SOUTHEAST CORNER OF A TRACT HERETOFORE CONVEYED BY HUGH W. HAMLIN AND

THE RE-ENTRANT ANGLE OF A TRACT OWNED BY G. C. GRIFFITH, THENCE RUNNING SOUTHERLY
FIVE HUNDRED FEET, THENCE RUNNING EASTERLY THIRTY-FIVE RODS MORE OR LESS, THENCE
