COUNTY, STATE OF OREGON, HAVE BARGAINED AND SOLD, AND BY THESE PRESENTS DO
GRANT, BARGAIN, SELL AND CONVEY UNTO SAID B. B. GERVAIS, HIS HEIRS AND ASSIGNS,
ALL THE FOLLOWING BOUNDED AND DESCRIBED REAL PROPERTY, SITUATED IN THE COUNTY
OF SKAMANIA AND STATE OF WASHINGTON.

THE NORTH ONE-HALF (N $\frac{1}{2}$) OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$) AND THE SOUTH-
WEST QUARTER (SW $\frac{1}{2}$) OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$) OF SECTION TWENTY-SEVEN
(27), TOWNSHIP TWO (2), NORTH RANGE FIVE (5) E. W.M., CONTAINING ONE HUNDRED
