TO US PAID BY T. W. BLOOD OF PORTLAND STATE OF OREGON, HAVE BARGAINED AND SOLD,  
AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO SAID T. W. BLOOD  
HIS HEIRS AND ASSIGNS, ALL THE FOLLOWING BOUNDED AND DESCRIBED REAL PROPERTY,  
SITUATED IN THE COUNTY OF SKAMANIS AND STATE OF WASHINGTON:
