KNOW ALL MEN BY THESE PRESENTS, THAT I, META GERALDINE WILDER, A WIDOW, OF THE CITY OF LONDON, ENGLAND, HAVE MADE, CONSTITUTED AND APPOINTED, AND BY THESE PRESENTS DO MAKE, CONSTITUTE AND APPOINT RICHARD WILDER, OF THE CITY OF PORTLAND, COUNTY OF MULTNOMAH AND STATE OF OREGON, MY TRUE AND LAWFUL ATTORNEY FOR ME AND IN MY NAME, PLACE AND STEAD, AND FOR MY USE AND BENEFIT TO ASK, DEMAND, SUE FOR, RECOVER, COLLECT, RECEIVE AND RECEIPT FOR SUCH SUMS OF MONEY, DEBTS, DUES, ACCOUNTS, LEGACIES, DEVISES, BEQUESTS, INTERESTS, DIVIDENDS, ANNUITIES AND DEMANDS WHATSOEVER, AS ARE NOW OR SHALL HEREAFTER BECOME DUE, OWING, PAYABLE OR BELONGING TO ME, AND HAVE, USE AND TAKE ALL LAWFUL WAYS AND MEANS IN MY NAME OR OTHERWISE FOR THE RECOVERY THEREOF, BY ATTACHMENT, ARRESTS, DISTRESS OR OTHERWISE, AND TO COMPROMISE AND AGREE FOR THE SAME, AND ACQUITTANCES OR OTHER SUFFICIENT DISCHARGES FOR THE SAME FOR ME AND IN MY NAME, TO MAKE, SEAL AND DELIVER; TO BARGAIN, CONTRACT, AGREE FOR, PURCHASE, RECEIVE AND TAKE LANDS, TENEMENTS, HEREDITAMENTS AND ACCEPT SEISIN AND POSSESSION OF ALL LANDS AND ALL DEEDS AND OTHER ASSURANCES IN THE LAW THEREFOR; TO BORROW MONEY AND TO LEASE, LET, DEMISE, BARGAIN, SELL, REMISE, RELEASE, CONVEY, MORTGAGE AND HYPOTHECATE LANDS, TENEMENTS AND HEREDITAMENTS UPON SUCH TERMS AND CONDITIONS AND UNDER SUCH COVENANTS AS HE SHALL THINK FIT.

ALSO TO BARGAIN AND AGREE FOR, BUY, SELL, MORTGAGE, HYPOTHECATE AND IN ANY AND EVERY WAY AND MANNER DEAL IN AND WITH GOODS, WARES AND MERCHANDISE, CHoses IN ACTION AND OTHER PROPERTY IN POSSESSION OR IN ACTION, AND TO MAKE, DO AND TRANSACT ALL AND EVERY KIND OF BUSINESS OF WHAT NATURE OR KIND SOEVER, AND ALSO FOR ME AND IN MY NAME, AND AS MY ACT AND DEED TO BORROW MONEY, TO SIGN, SEAL, EXECUTE, DELIVER AND ACKNOWLEDGE SUCH DEEDS, LEASES, RELEASES AND ASSIGNMENTS OF LEASES, COVENANTS, INDENTURES, AGREEMENTS, MORTGAGES, HYPOTHCATIONS, BOTTOMRIES, CHARTER-PARTIES, BILLS OF LADING, BILLS, BONDS, NOTES, RECEIPTS, EVIDENCES OF DEBT, RELEASES AND SATISFACTIONS OF MORTGAGE, JUDGMENT AND OTHER DEBTS, AND SUCH OTHER INSTRUMENTS IN WRITING OF WHATEVER KIND AND NATURE AS MAY BE NECESSARY OR PROPER IN THE PREMISES.

GIVING AND GRANTING UNTO MY SAID ATTORNEY FULL POWER AND AUTHORITY TO DO AND PERFORM ALL AND EVERY ACT AND THING WHATSOEVER REQUISITE AND NECESSARY TO BE DONE IN AND ABOUT THE PREMISES, AS FULLY TO ALL INTENTS AND PURPOSES AS I MIGHT OR COULD DO IF PERSONALLY PRESENT, AND WITH FULL POWER OF SUBSTITUTION OR REVOCATION, HEREBY RETIFYING AND CONFIRMING ALL THAT MY SAID ATTORNEY OR HIS SUBSTITUTION OR SUBSTITUTES SHALL LAWFULLY DO OR CAUSE TO BE DONE BY VIRTUE OF THESE PRESENTS.
