ORDER APPOINTING ADMINISTRATOR C.T.A.

NOW ON THIS DATE COMES ON TO BE HEARD THE PETITION OF RICHARD WILDER, PRAYING FOR AN ORDER APPOINTING RICHARD WILDER ADMINISTRATOR C.T.A. OF THE ESTATE OF FRANK WILDER, DECEASED, AND THAT LETTERS OF ADMINISTRATION BE ISSUED TO HIM, AND FOR HIS DISCHARGE AS SPECIAL ADMINISTRATOR:

AND IT APPEARING THAT THE SAID DECEASED WAS KILLED SOMEWHERE IN FRANCE ON MARCH 31ST 1916, AND THAT AT THE TIME OF HIS DEATH HE WAS POSSESSED OF REAL PROPERTY SITUATED IN THE COUNTY OF MULTNOMAH, STATE OF OREGON;

AND IT FURTHER APPEARING THAT THE SAID DECEASED LEFT A WILL WHICH WAS OFFERED AND ADMITTED TO PROBATE IN THE PROBATE DIVISION OF THE HIGH COURT OF JUSTICE, LONDON, ENGLAND, AND THAT A CERTIFIED COPY OF THE SAID WILL AND THE OFFICIAL OATH LEADING TO PROBATE, TOGETHER WITH THE ORDER ADMITTING SAME TO PROBATE, DULY CERTIFIED BY THE REGISTRAR OF THE SAID COURT AND AUTHENTICATED BY THE CERTIFICATE OF THE VICE CONSUL OF THE UNITED STATES OF AMERICA FOR GREAT BRITAIN AND IRELAND AT LONDON, ENGLAND, HAS BEEN DULY FILED IN THIS COURT;

AND IT FURTHER APPEARING THAT THE SAID RICHARD WILDER IS THE NEAREST RELATIVE OF SAID DECEASED, BEING A BROTHER OF SAID DECEASED, AND IS A RESIDENT OF MULTNOMAH COUNTY, STATE OF OREGON, AND ENTITLED TO APPOINTMENT AS ADMINISTRATOR C.T.A.;

AND IT FURTHER APPEARING THAT THE SAID RICHARD WILDER HAS HERETOFORE BEEN APPOINTED SPECIAL ADMINISTRATOR OF THE SAID ESTATE AND AS SUCH SPECIAL ADMINISTRATOR RECEIVED THE SUM OF \$38.74 AND NO MORE, AND HAS EXPENDED THE SUM OF \$8.50, CLERK'S FEES ON FILING THE PETITION IN PROBATE, AND THE SUM OF \$2.50 COST OF PUBLISHING NOTICE TO CREDITORS, AND THAT HE HAS LEFT IN HIS POSSESSION THE SUM OF \$27.74;

IT IS THEREFORE ORDERED, THAT RICHARD WILDER BE AND HE IS HEREBY APPOINTED ADMINISTRATOR C.T.A. OF THE ESTATE OF FRANK WILDER, DECEASED, AND THAT LETTERS OF ADMINISTRATION BE ISSUED TO HIM UPON FILING THE OATH AS SUCH ADMINISTRATOR; THAT RICHARD WILDER BE AND HE IS HEREBY DISCHARGED AS SPECIAL ADMINISTRATOR, AND THAT THE BOND HERETOFORE DEPOSITED IN THIS COURT BY RICHARD WILDER AS SUCH SPECIAL ADMINISTRATOR BE CONTINUED AS THE BOND OF RICHARD WILDER, ADMINISTRATOR C.T.A. UPON FILING THE CONSENT THERETO BY THE SURETY ON THE SAID BOND, AND THAT THE INVENTORY HERETOFORE FILED BY THE SPECIAL ADMINISTRATOR BE ACCEPTED AND TAKEN AS THE INVENTORY OF THE ESTATE OF FRANK WILDER, DECEASED, BY THE ADMINISTRATOR C.T.A.
