THIRD: I HEREBY NOMINATE AND APPOINT MY SAID WIFE THE EXECUTRIX OF THIS MY LAST WILL AND TESTAMENT SHE TO ACT WITHOUT BEING REQUIRED TO GIVE ANY BOND OR UNDERTAKING AS SUCH AND I HEREBY REVOKE ALL FORMER WILLS BY ME MADE.
