THIS COURT HAVING HERETOFORE MADE AN ORDER APPROVING AND ALLOWING THE FINAL ACCOUNT OF RICHARD WILDER, ADMINISTRATOR WITH THE WILL ANNEXED OF THE ESTATE OF FRANK WILDER, DECEASED, AND ORDERING DELIVERY OF THE PERSONAL PROPERTY TO META GERALDINE WILDER, WIDOW AND SOLE HEIR-AT-LAW OF SAID DECEASED, AND ORDERING THAT A RECEIPT BE FILED BY SAID META GERALDINE WILDER, SHOWING THE PAYMENT AND DELIVERY TO HER OF ALL THE PERSONAL PROPERTY OF SAID ESTATE, AND REQUIRING THAT A RECEIPT BE FILED, SHOWING PAYMENT OF THE FEES FOR THE PUBLICATION OF NOTICE OF HEARING OF FINAL ACCOUNTS, AND ALSO A RECEIPT TO BE FILED, SHOWING THAT THE INHERITANCE TAX TO THE STATE OF OREGON HAS BEEN FULLY PAID; AND

IT APPEARING THAT THE RECEIPT OF SAID META GERALDINE WILDER, SHOWING THE DELIVERY TO HER OF ALL PERSONAL PROPERTY OF SAID ESTATE, HAS BEEN FILED ON HER BEHALF BY RICHARD WILDER, AS HER ATTORNEY-IN-FACT, WHICH THIS COURT HEREBY FINDS SUFFICIENT; AND

IT FURTHER APPEARING THAT A RECEIPT HAS BEEN FILED, SHOWING THAT THE FEES FOR THE PUBLICATION OF THE NOTICE OF HEARING OF FINAL ACCOUNT, HAVE BEEN PAID; AND

IT FURTHER APPEARING THAT A RECEIPT HAS BEEN FILED, SHOWING THAT THE INHERITANCE TAX DUE TO THE STATE OF OREGON HAS BEEN FULLY PAID;
