THE FOLLOWING DESCRIBED TRACT, LOT, OR PARCEL OF LAND, SITUATED, LYING AND  
BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, PARTICULARLY BOUNDED AND  
DESCRIBED AS FOLLOWS, TO-WIT:

ALL TIDE AND SHORE LANDS BELONGING TO THE STATE OF WASHINGTON  
BORDERING UPON SPIRIT LAKE IN SECTIONS ONE (1) TEN (10) ELEVEN (11) TWELVE  
(12) THIRTEEN (13) FOURTEEN (14) AND FIFTEEN (15) TOWNSHIP NINE (9) NORTH,  
RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN IN SKAMANIA COUNTY, WASHINGTON.  
THIS DEED IS GIVEN TO CORRECT ONE GIVEN UNDER DATE OF NOVEMBER 28TH. 1919, FOUND  
IN BOOK R DEEDS RECORDS AT PAGE, 492, RECORDS OF SKAMANIA COUNTY, WASHINGTON.  
TOGETHER WITH ALL AND SINGULAR, THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES  
THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, AND THE REVERSION AND REVER-  
SIONS, REMAINDER AND REMAINDERS, RENTS, ISSUES AND PROFITS THEREOF.
