I, J. W. PAGE, BEING FIRST DULY SWORN ON OATH SAY THAT I AM AND HAVE BEEN FOR MORE THAN FIFTEEN YEARS LAST PAST, A RESIDENT OF CARSON, SKAMANIA COUNTY, WASHINGTON, THAT ARCHY N. PAGE, WHO ACQUIRED TITLE TO THE TRACT OF LAND IN SKAMANIA COUNTY, WASHINGTON, DESCRIBED AS:

"BEGINNING AT A POINT (30) THIRTY FEET EAST AND (101) ONE HUNDRED AND ONE RODS AND (13 $\frac{1}{2}$) THIRTEEN AND ONE-HALF FEET NORTH OF THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION TWENTY-ONE (21), TOWNSHIP THREE (3) NORTH OF RANGE EIGHT (8) EAST OF THE WILLAMETTE MERIDIAN, RUNNING THENCE EAST (58) FIFTY-EIGHT RODS (13 $\frac{2}{3}$) THIRTEEN AND TWO-THIRDS FEET, THENCE NORTH (20) TWENTY RODS (12 $\frac{1}{2}$) TWELVE AND ONE-HALF FEET, THENCE WEST (58) FIFTY-EIGHT RODS (13 $\frac{2}{3}$) THIRTEEN AND TWO-THIRDS FEET, THENCE SOUTH (20) TWENTY RODS (12 $\frac{1}{2}$) TWELVE AND ONE-HALF FEET TO THE POINT OF BEGINNING." BY WARRANTY DEED BEARING DATE MARCH 25, 1911, EXECUTED BY W. J. ROSS AND AMANDA E. ROSS IN HIS FAVOR, FILED FOR RECORD MARCH 11, 1915 AND RECORDED IN BOOK P OF DEEDS, PAGE 216, RECORDS OF THE AUDITOR OF SAID SKAMANIA COUNTY, WASHINGTON, WAS MY SON, NOW DECEASED, AND THAT HE WAS THE IDENTICAL PERSON WHO AS A. N. PAGE, A SINGLE MAN, LATER, ON THE 23RD DAY OF JUNE 1911, BY WARRANTY DEED BEARING SAID DATE, CONVEYED SAID PROPERTY TO J. W. PAGE, THIS AFFIANT, WHICH SAID DEED WAS FILED FOR RECORD ON THE 11TH DAY OF MARCH, 1915 AND RECORDED IN BOOK P OF DEEDS, PAGE 218, RECORDS OF THE AUDITOR OF SAID SKAMANIA COUNTY, WASHINGTON.
