THIS INDENTURE, MADE THIS 20TH DAY OF SEPTEMBER A.D. 1924, BY AND BETWEEN RICHARD H. TURK, A BACHELOR, OF THE COUNTY OF SKAMANIA, AND STATE OF WASHINGTON, HEREINAFTER CALLED THE MORTGAGOR, AND THE OREGON MORTGAGE COMPANY, LIMITED, HEREINAFTER CALLED THE MORTGAGEE,

WITNESSETH: THAT THE SAID MORTGAGOR, FOR AND IN CONSIDERATION OF THE SUM OF SEVEN THOUSAND & 00/100 DOLLARS, UNITED STATES GOLD COIN, TO HIM IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD AND CONVEYED AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID MORTGAGEE, ITS SUCCESSORS, LEGAL REPRESENTATIVES AND ASSIGNS, THOSE CERTAIN PREMISES SITUATE IN THE COUNTY OF SKAMANIA, AND STATE OF WASHINGTON, AND DESCRIBED AS FOLLOWS, TO-WIT:

THE SOUTH HALF OF THE NORTHWEST QUARTER ( $S\frac{1}{2}$  NW $\frac{1}{4}$ ) AND THE SOUTH HALF OF THE NORTHEAST QUARTER ( $S\frac{1}{2}$  NE $\frac{1}{4}$ ) OF SECTION EIGHTEEN (18), IN TOWNSHIP ONE (1), NORTH OF RANGE FIVE (5) EAST OF WILLAMETTE MERIDIAN; EXCEPTING THEREFROM A TEN ACRE (10) TRACT IN THE SOUTHWEST (SW) CORNER BEING TWENTY (20) RODS WIDE NORTH AND SOUTH AND EIGHTY (80) RODS WIDE EAST AND WEST; THE LAND HEREBY CONVEYED BEING ONE HUNDRED
