WITNESSETH, That the said part... of the first part, for and in consideration of the sum of One Dollar and other valuable considerations of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged do by these presents, remise, release and forever QUIT-CLAIM unto the said party of the second part, and to its heirs, assigns, the following described tract, lot, or parcel of land, situated, lying and being in the County of Skamania, State of Washington, particularly bounded and described as follows, to-wit:

All that portion of Lot Three (3) Section Thirty-six (36), Township Two (2) North Range Six (6) East of the Willamette Meridian, Skamania County, Washington, lying East of the center of Little Creek as at present located to the line between Sections 35 and 26 in said Township 2.
