Nine and 1/16 acres of the Southwest quarter of Section Twenty-five (25) in Township Three (3), North of Range Eight (8) East of Willamette Meridian, being Fifty (50) Rods South, Twenty-nine (29) Rods East, Fifty (50) Rods North and Twenty-nine (29) Rods West to the Northwest corner post of said quarter section. together with all and singular the tenements, hereditaments and appurtenances thereto belonging, or in any wise appertaining, and also all our estate, right, title and interest in and to the same, including dower and claim of dower.

TO HAVE AND TO HOLD, the above described and granted premises unto the said Frank Fruiht, his heirs and assigns forever. And the grantors above named do covenant to and with the above named grantee, his heirs and assigns, that the above granted premises are free from all incumbrances, and that they will, and their heirs, executors and administrators shall, warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
